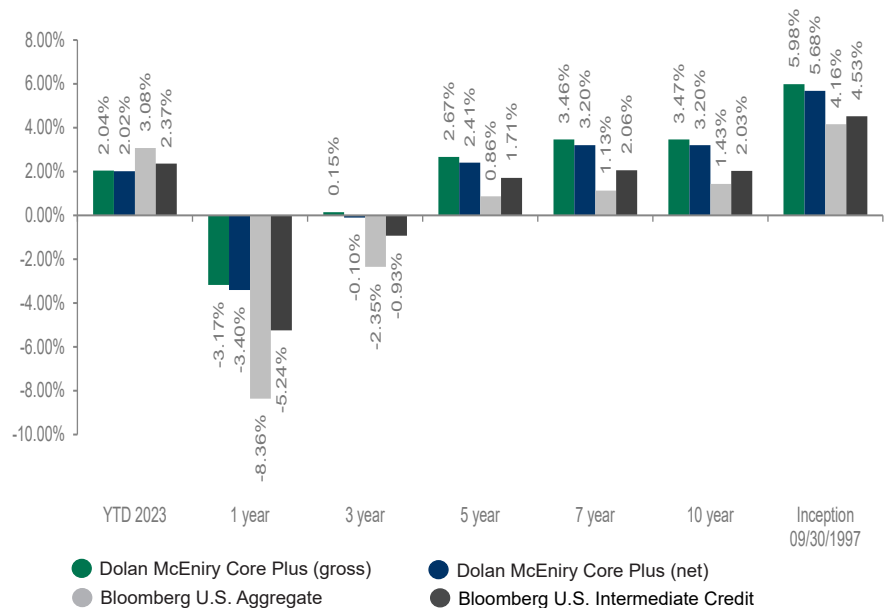

Dolan McEnery Core Plus Strategy Overview

Dolan McEnery Core Plus is a fixed income investment product that utilizes U.S. corporate investment grade, U.S. corporate high yield and U.S. Treasury securities. Dolan McEnery Core Plus is approximately 75% U.S. corporate investment grade bonds and 25% U.S. corporate high yield bonds. The Dolan McEnery Core Plus Composite was established and created on September 30, 1997.

Investment Strategy and Process

Dolan McEnery searches for bonds that trade at wide spreads and attractive prices but are issued by companies with acceptable levels of credit risk. The firm's core competence is credit analysis and it does its credit research in-house, not relying at all on credit ratings or third party research. The firm takes a lender's approach to fixed income investing.

Dolan McEnery creates concentrated portfolios of its best ideas. The number of issuers in the product ranges from 25 to 45. This number of holdings provides diversification and yet allows clients to benefit from the firm's analysis.

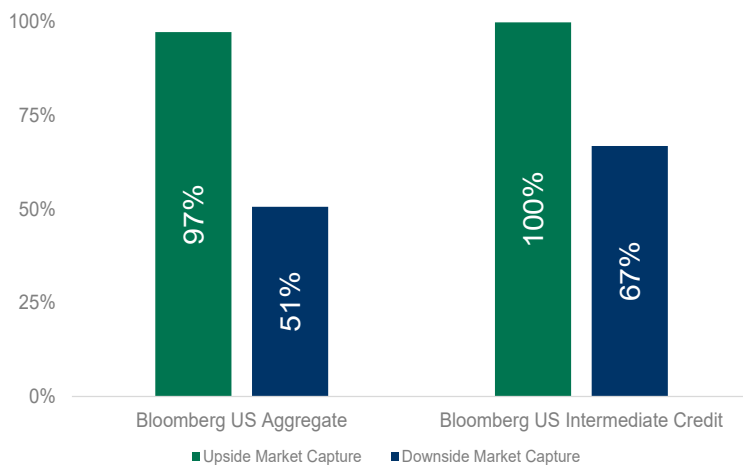

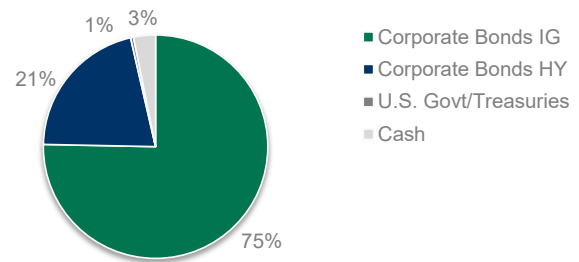

Duration Distribution (%)

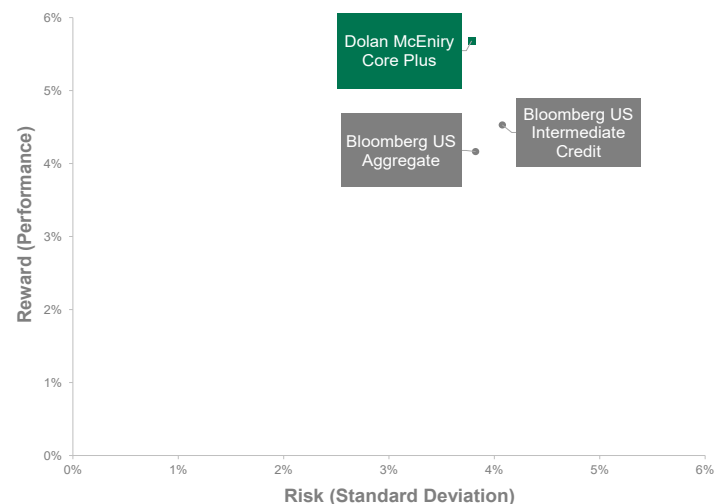

Market Review

During the first month of 2023, the market reversed course after a difficult year and positive returns were seen in many equity and fixed income markets. High inflation was one of the key stories in 2022. Economic data during the month of January indicate that, while still elevated, inflation may be decelerating.

After raising the Federal Funds rate significantly in 2022, the market expects the Federal Reserve to be nearing the end of the rate hiking cycle. As a result of the actions taken by the Federal Reserve over the last year, yields are among the highest they have been in over a decade.

During the month, treasury rates decreased, and the curve remained inverted as the 10 year U.S. Treasury yield decreased from 3.88% to 3.51%, the 5 year yield decreased from 4.01% to 3.62% and the 2 year yield decreased from 4.43% to 4.21%.

Per Bloomberg data, spreads of corporate investment grade bonds tightened 13 basis points during the month to an average option adjusted spread ("OAS") of +117 basis points. The OAS of the Bloomberg Corporate High Yield Index tightened 49 basis points to +420 basis points at month end.

Portfolio Commentary

During the month, the Dolan McEniry Core Plus Composite had a gross return of +2.04% and +2.02% net versus the Bloomberg U.S. Aggregate Bond benchmark return of +3.08% and Bloomberg U.S. Intermediate Credit benchmark return of +2.37%. Sector attribution versus the benchmarks is provided in the following table:

On a relative basis, the Dolan McEniry Core Plus Composite underperformed the Bloomberg U.S. Aggregate Bond Index by 104 basis points gross for the year. The composite's underperformance was driven by its relative underperformance in the corporate investment grade sector. The underperformance was partially offset by the allocation and performance in the corporate high yield sector. The yield curve positioning and duration had a negative effect on relative performance versus the benchmark.

On a relative basis, the Dolan McEniry Core Plus Composite underperformed the Bloomberg U.S. Credit Intermediate Index by 33 basis points gross for the year. The composite's underperformance was driven by its relative underperformance in the corporate investment grade sector. The underperformance was partially offset by the allocation and performance in the corporate high yield sector. The yield

Outlook and Strategy

Dolan McEniry believes that client portfolios are positioned to provide reasonable absolute and relative returns going forward. Dolan McEniry's core competence is credit analysis, and we focus on a company's ability to generate generous amounts of free cash flow over time in relation to its indebtedness. Investment safety and risk mitigation are of primary importance as we continue to search for undervalued fixed income securities. As of January 31st, the Dolan McEniry Core Plus Composite had a +107 basis point yield premium and shorter duration to the Bloomberg U.S. Aggregate Bond and a +59 basis point yield premium and similar duration versus the Bloomberg U.S. Intermediate Credit. We believe these stats will allow the portfolio to perform well versus the benchmarks over time.

Definition of the Firm

Dolan McEnery Capital Management, LLC is an independent investment management firm established in 1997 and is an SEC registered investment adviser. Registration of an adviser does not imply a certain level of skill or training. Dolan McEnery Capital Management, LLC manages fixed income accounts utilizing Dolan McEnery's specific strategies for institutional and individual clients.

Definition of the Composite

Dolan McEnery Core Plus is a fixed income investment product benchmarked against the Bloomberg U.S. Aggregate Index or the Bloomberg U.S. Intermediate Credit Index. In this strategy, the firm utilizes U.S. corporate investment grade, U.S. corporate high yield and U.S. Treasury securities. Dolan McEnery Core Plus is approximately 75% U.S. corporate investment grade bonds and 25% U.S. corporate high yield bonds. The Dolan McEnery Core Plus Composite was established and created on September 30, 1997.

Dolan McEnery began including accounts that are valued under \$1,000,000 USD in the composite as of December 31, 2009. Prior to December 31, 2009 an account had to have a value over \$1,000,000 USD to be included in the composite.

Non-fee paying accounts represented less than 2% of the composite assets for all periods shown.

Benchmark

Bloomberg U.S. Aggregate Index

The Index is a broad-based flagship benchmark that measures the investment grade, U.S. dollar-denominated, fixed-rate taxable bond market. The Index includes Treasuries, government-related and corporate securities, MBS (agency fixed-rate and hybrid ARM pass-throughs), ABS, and CMBS (agency and non-agency).

Bloomberg U.S. Intermediate Credit Index

The Index is the intermediate component of the Bloomberg U.S. Credit Index. The Bloomberg U.S. Credit Index measures the investment grade, US dollar-denominated, fixed-rate, taxable, corporate and government –related bond markets. It is composed of the US Corporate Index and a non-corporate component that includes foreign agencies, sovereigns, supranationals, and local authorities.

Intra-month cash flows from interest and principal payments contribute to monthly Index returns but are not reinvested at a short-term reinvestment rate between rebalance dates. At each rebalancing, cash is effectively reinvested into the returns universe for the following month so that Index results over two or more months reflect monthly compounding. One cannot invest directly in an Index.

Dispersion

The dispersion of annual returns is measured by the asset weighted standard deviation across gross portfolio returns represented within the composite for the full year.

Performance

Gross returns are presented gross of management fees, custodial fees, and withholding taxes, but net of direct trading expenses. Net-of-fee returns are net of actual investment management fees and direct trading expenses. All returns are based in U.S. dollars and computed using a time-weighted total return. Composite returns are asset weighted individual portfolios computed monthly. Returns for periods exceeding 12 months are annualized.

The Dolan McEniry Core Plus Composite includes both price performance and coupon/dividend income as do the Bloomberg U.S. Aggregate Index and Bloomberg U.S. Intermediate Credit Index. Results reflect the reinvestment of dividends, interest and other earnings.
