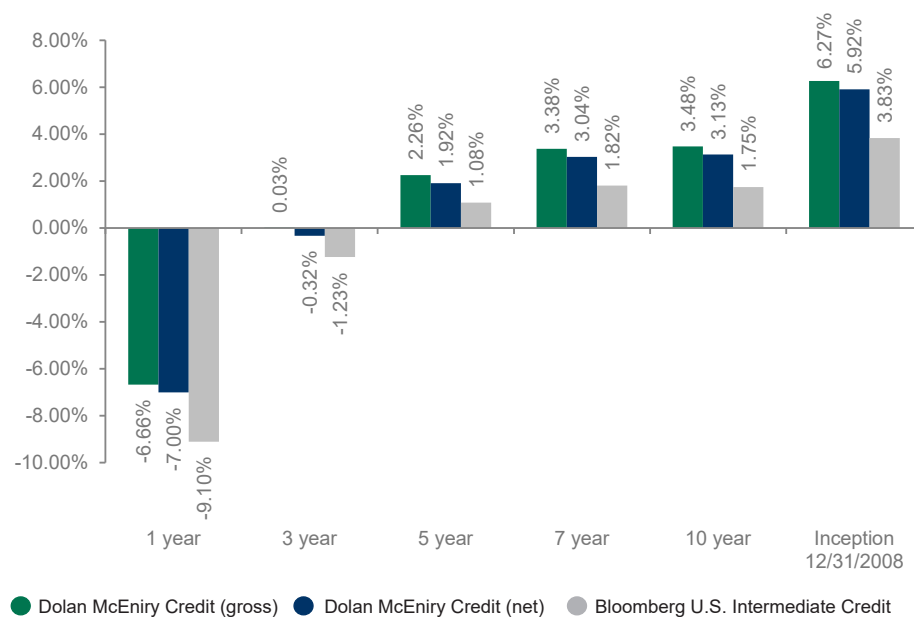

Dolan McEniry Credit Strategy Overview

Dolan McEniry Credit is a fixed income investment product that utilizes U.S. corporate investment grade, U.S. corporate high yield and U.S. Treasury securities. Dolan McEniry Credit is approximately 50% U.S. corporate investment grade bonds and 50% U.S. corporate high yield bonds. The Dolan McEniry Credit Composite was established and created on December 31, 2008.

Investment Strategy and Process

Dolan McEniry searches for bonds that trade at wide spreads and attractive prices but are issued by companies with acceptable levels of credit risk. The firm's core competence is credit analysis and it does its credit research in-house, not relying at all on credit ratings or third party research. The firm takes a lender's approach to fixed income investing.

Dolan McEniry creates concentrated portfolios of its best ideas. The number of issuers in the product ranges from 25 to 45. This number of holdings provides diversification and yet allows clients to benefit from the firm's analysis.

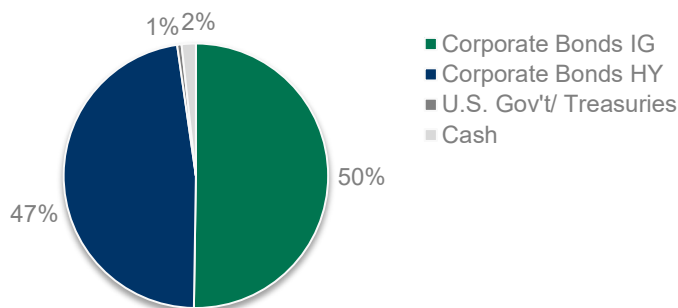

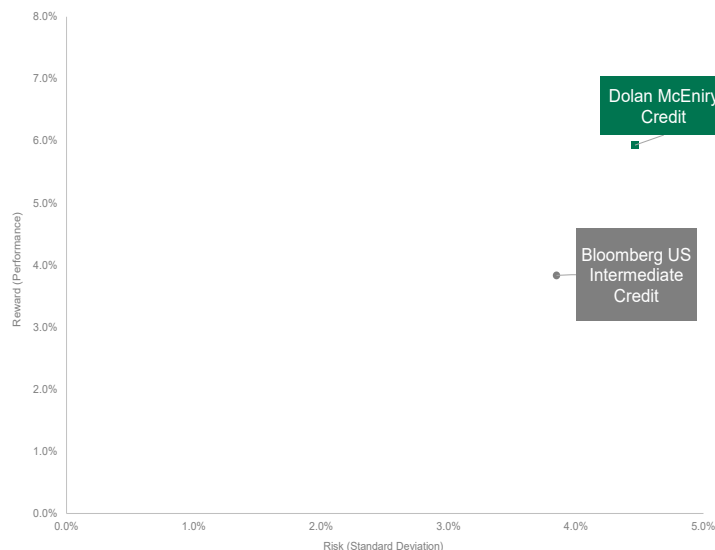

Market Review

During 2022, negative returns were seen in many equity and fixed income indices as markets grappled with historically high inflation, supply chain issues, and geopolitical concerns.

In an attempt to combat this dramatic rise in inflation, the Federal Reserve took historic action by raising the Federal Funds rate on seven different occasions. The Federal Reserve increased the Federal Funds rate range from 0.00%-0.25% at the beginning of the year to 4.25%-4.50% at the end. As a result, treasury yields were substantially higher for the year and are among the highest they have been in over a decade.

During the year, treasury rates increased, and the curve remained inverted as the 10 year U.S. Treasury yield increased from 1.51% to 3.88%, the 5 year yield increased from 1.26% to 4.01% and the 2 year yield increased from 0.74% to 4.43%.

Per Bloomberg data, spreads of corporate investment grade bonds widened 38 basis points during the year to an average option adjusted spread ("OAS") of +130 basis points. The OAS of the Bloomberg Corporate High Yield Index widened 186 basis points to +469 basis points at year end.

Portfolio Commentary

During the year, the Dolan McEniry Credit Composite had a gross return of -6.66% and -7.00% net versus the benchmark which returned -9.10%. Sector attribution versus the benchmark is provided in the following table:

On a relative basis, the Dolan McEniry Credit Composite outperformed the Bloomberg Intermediate Credit Index by 244 basis points during the year. The outperformance was driven by strong performance in the corporate high yield segment as well as relative outperformance in the corporate investment grade segment. During the year, yield curve positioning and duration had minimal effect on performance versus the benchmark.

Outlook and Strategy

Dolan McEniry believes that client portfolios are positioned to provide reasonable absolute and relative returns going forward. Dolan McEniry's core competence is credit analysis, and we focus on a company's ability to generate generous amounts of free cash flow over time in relation to its indebtedness. Investment safety and risk mitigation are of primary importance as we continue to search for undervalued fixed income securities. As of December 31st, the Dolan McEniry Credit Composite had a +92 basis point yield premium and similar duration to the Bloomberg U.S. Intermediate Credit, which we believe will allow the portfolio to perform well versus the benchmark over time.

Dolan McEnery Capital Management, LLC manages fixed income accounts utilizing Dolan McEnery's specific strategies for institutional and individual clients.

Definition of the Composite

Dolan McEnery Credit is a fixed income investment product benchmarked against the Bloomberg U.S. Intermediate Credit Index. In this strategy, the firm utilizes U.S. corporate investment grade, U.S. corporate high yield and U.S. Treasury securities. Dolan McEnery Credit has averaged approximately 50% U.S. corporate investment grade bonds and 50% U.S. corporate high yield bonds. The Dolan McEnery Credit Composite was established and created on December 31, 2008.

Non-fee paying accounts represented less than 2% of the composite assets for all periods shown.

Benchmark

Bloomberg U.S. Intermediate Credit Index The Index is the intermediate component of the Bloomberg U.S. Credit Index. The Bloomberg U.S. Credit Index measures the investment grade, US dollar-denominated, fixed-rate, taxable, corporate and government-related bond markets. It is composed of the US Corporate Index and a non-corporate component that includes foreign agencies, sovereigns, supranationals, and local authorities.

Intra-month cash flows from interest and principal payments contribute to monthly Index returns but are not reinvested at a short-term reinvestment rate between rebalance dates. At each rebalancing, cash is effectively reinvested into the returns universe for the following month so that Index results over two or more months reflect monthly compounding. One cannot invest directly in an Index.

Dispersion

The dispersion of annual returns is measured by the asset weighted standard deviation across gross portfolio returns represented within the composite for the full year.

Performance

Gross returns are presented gross of management fees, custodial fees, and withholding taxes, but net of direct trading expenses. Net-of-fee returns are net of actual investment management fees and direct trading expenses. All returns are based in U.S. dollars and computed using a time-weighted total return. Composite returns are asset weighted individual portfolios computed monthly. Returns for periods exceeding 12 months are annualized. The Dolan McEniry Credit Composite includes both price performance and coupon/dividend income as does the Bloomberg U.S Intermediate Credit Index. Results reflect the reinvestment of dividends, interest and other earnings. The Dolan McEniry performance reflected above is not necessarily indicative of future results and, as a composite of different accounts, does not necessarily reflect the exact performance of any specific account.
