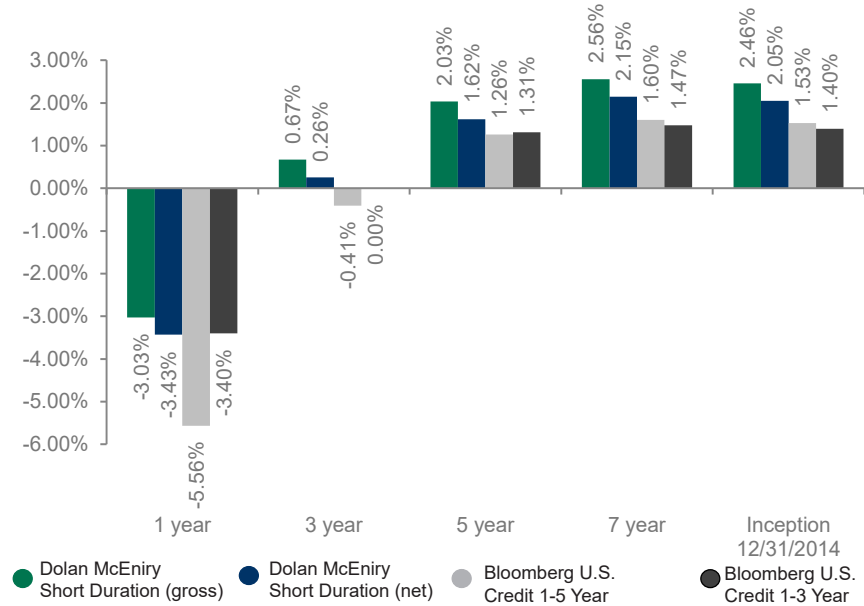

Dolan McEnery Short Duration Strategy Overview

Dolan McEnery Short Duration is a fixed income investment product that utilizes U.S. corporate investment grade, U.S. corporate high yield and U.S. Treasury securities. Dolan McEnery Short Duration is approximately 60% U.S. corporate investment grade bonds and 40% U.S. corporate high yield bonds. The composite has an average duration target of 3 years or less. The Dolan McEnery Short Duration Composite was created on December 31, 2015 and includes short duration mandate accounts going back to December 31, 2014.

Investment Strategy and Process

Dolan McEnery searches for bonds that trade at wide spreads and attractive prices but are issued by companies with acceptable levels of credit risk. The firm's core competence is credit analysis and it does its credit research in-house, not relying at all on credit ratings or third party research. The firm takes a lender's approach to fixed income investing.

Dolan McEnery creates concentrated portfolios of its best ideas. The number of issuers in the product ranges from 25 to 45. This number of holdings provides diversification and yet allows clients to benefit from the firm's analysis.

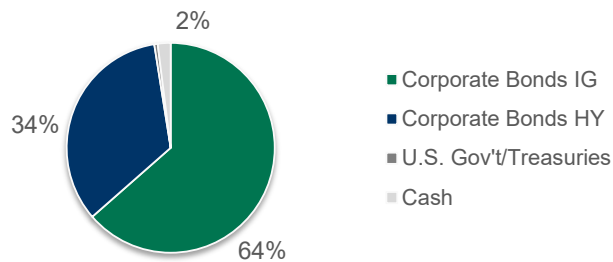

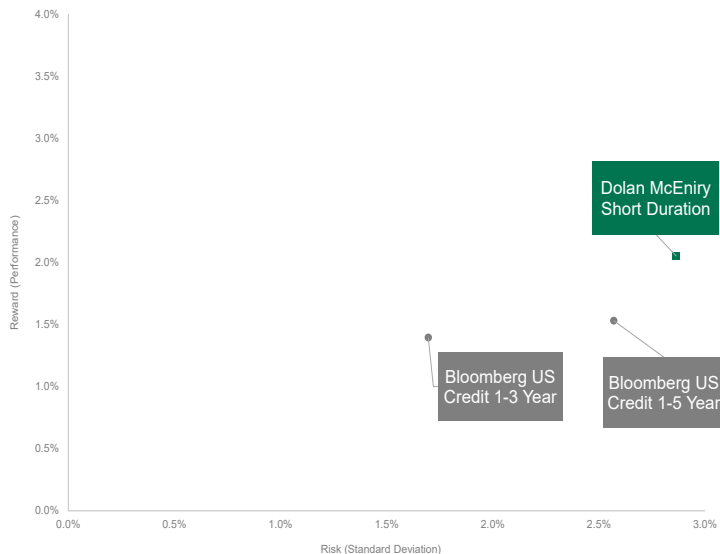

Market Review

During 2022, negative returns were seen in many equity and fixed income indices as markets grappled with historically high inflation, supply chain issues, and geopolitical concerns.

In an attempt to combat this dramatic rise in inflation, the Federal Reserve took historic action by raising the Federal Funds rate on seven different occasions. The Federal Reserve increased the Federal Funds rate range from 0.00%-0.25% at the beginning of the year to 4.25%-4.50% at the end. As a result, treasury yields were substantially higher for the year and are among the highest they have been in over a decade.

During the year, treasury rates increased, and the curve remained inverted as the 10 year U.S. Treasury yield increased from 1.51% to 3.88%, the 5 year yield increased from 1.26% to 4.01% and the 2 year yield increased from 0.74% to 4.43%.

Per Bloomberg data, spreads of corporate investment grade bonds widened 38 basis points during the year to an average option adjusted spread ("OAS") of +130 basis points. The OAS of the Bloomberg Corporate High Yield Index widened 186 basis points to +469 basis points at year end.

Portfolio Commentary

For the year, the Dolan McEniry Short Duration Composite had a gross return of -3.03% and -3.43% net versus the Bloomberg Credit 1-5 Year Index which returned -5.56% and the Bloomberg Credit 1-3 Year Index which returned -3.40%. Sector attribution versus the benchmark is provided in the following table:

The Dolan McEniry Short Duration Composite outperformed the Credit 1-5 Year benchmark by 253 basis points gross during the year. The outperformance was driven by security selection. Duration and yield curve positioning had a positive effect on performance relative to the benchmark.

The Dolan McEniry Short Duration Composite outperformed the Credit 1-3 Year benchmark by 37 basis points gross during the year. The outperformance was driven by security selection. Duration and yield curve positioning had a minimal effect on performance relative to the benchmark.

Outlook and Strategy

Dolan McEniry believes that client portfolios are positioned to provide reasonable absolute and relative returns going forward. Dolan McEniry's core competence is credit analysis, and we focus on a company's ability to generate generous amounts of free cash flow over time in relation to its indebtedness. Investment safety and risk mitigation are of primary importance as we continue to search for undervalued fixed income securities. As of December 31st, the Dolan McEniry Short Duration Composite had a +76 basis point yield premium to the Credit 1-5 Year benchmark and a +77 basis point yield premium to the Credit 1-3 Year benchmark, which we believe will allow the portfolio to perform well versus the benchmarks over time.

Definition of the Composite

In this strategy, the firm utilizes U.S. corporate investment grade, U.S. corporate high yield and U.S. Treasury securities. Dolan McEnery Short Duration is approximately 60% U.S. corporate investment grade bonds and 40% U.S. corporate high yield bonds. The composite has an average duration target of 3 years or less. The Dolan McEnery Short Duration Composite was created on December 31, 2015 and includes short duration mandate accounts going back to December 31, 2014.

Benchmark

Bloomberg U.S. Credit 1-5 Year Index This Index is the 1-5 year maturity component of the Bloomberg U.S. Credit Index. Must have a maturity from 1 up to (but not including) 5 years. The Index includes both corporate and non-corporate sectors. The corporate sectors are Industrial, Utility, and Finance, which include both U.S. and non-U.S. corporations. The non-corporate sectors are Sovereign, Supranational, Foreign Agency, and Foreign Local Government.

Bloomberg U.S. Credit 1-3 Year Index

This Index is the 1-3 year maturity component of the Bloomberg U.S. Credit Index. Must have a maturity from 1 up to (but not including) 3 years. The Index includes both corporate and non-corporate sectors. The corporate sectors are Industrial, Utility, and Finance, which include both U.S. and non-U.S. corporations. The non-corporate sectors are Sovereign, Supranational, Foreign Agency, and Foreign Local Government.

Intra-month cash flows from interest and principal payments contribute to monthly Index returns but are not reinvested at a short-term reinvestment rate between rebalance dates. At each rebalancing, cash is effectively reinvested into the returns universe for the following month so that Index results over two or more months reflect monthly compounding. One cannot invest directly in an Index.

Dispersion

The dispersion of annual returns is measured by the asset weighted standard deviation across gross portfolio returns represented within the composite for the full year.

Performance

Gross returns are presented gross of management fees, custodial fees, and withholding taxes, but net of direct trading expenses. Net-of-fee returns are based on a model 0.40% (40bps) investment management fee applied monthly and direct trading expenses. All returns are based in U.S. dollars and computed using a time-weighted total return. Composite returns are asset weighted individual portfolios computed monthly. Returns for periods exceeding 12 months are annualized. The Dolan McEniry Short Duration Composite includes both price performance and coupon/dividend income as does the Bloomberg U.S. Credit 1-5 Year Index. Results reflect the reinvestment of dividends, interest and other earnings.
