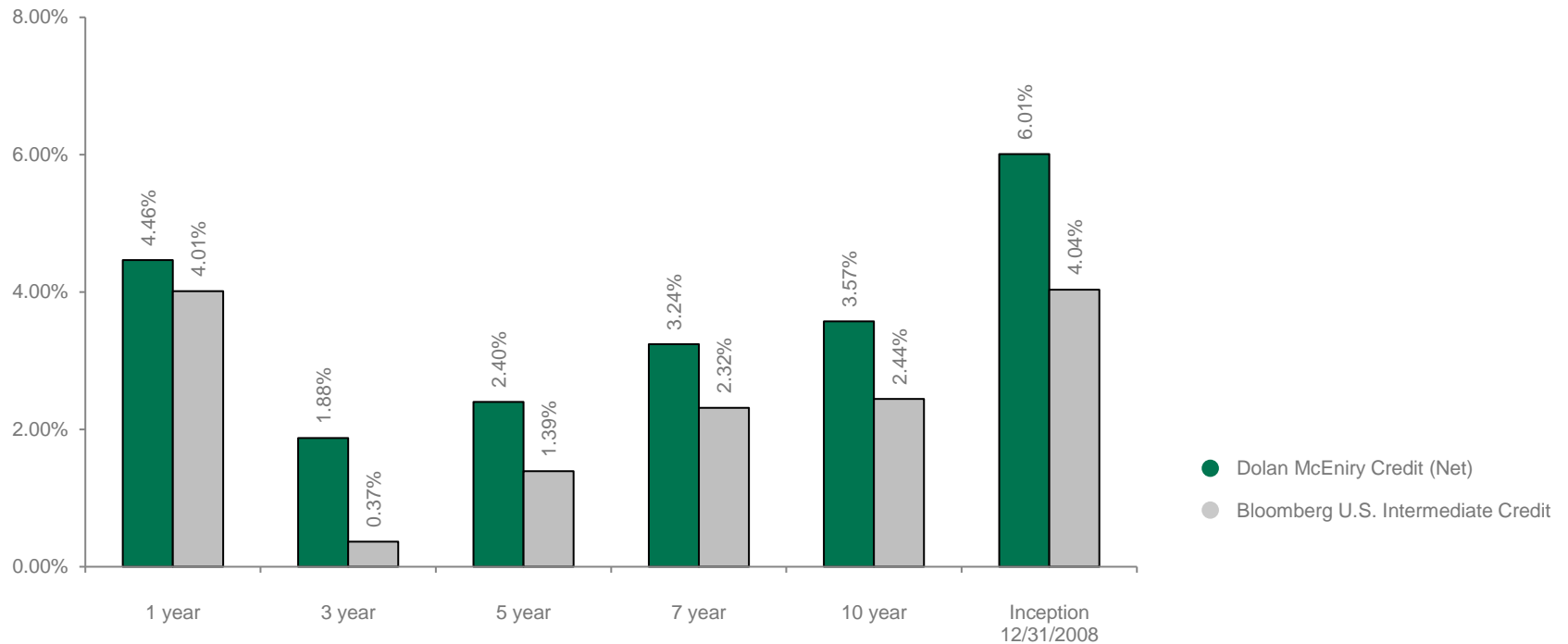

Data through December 31, 2024

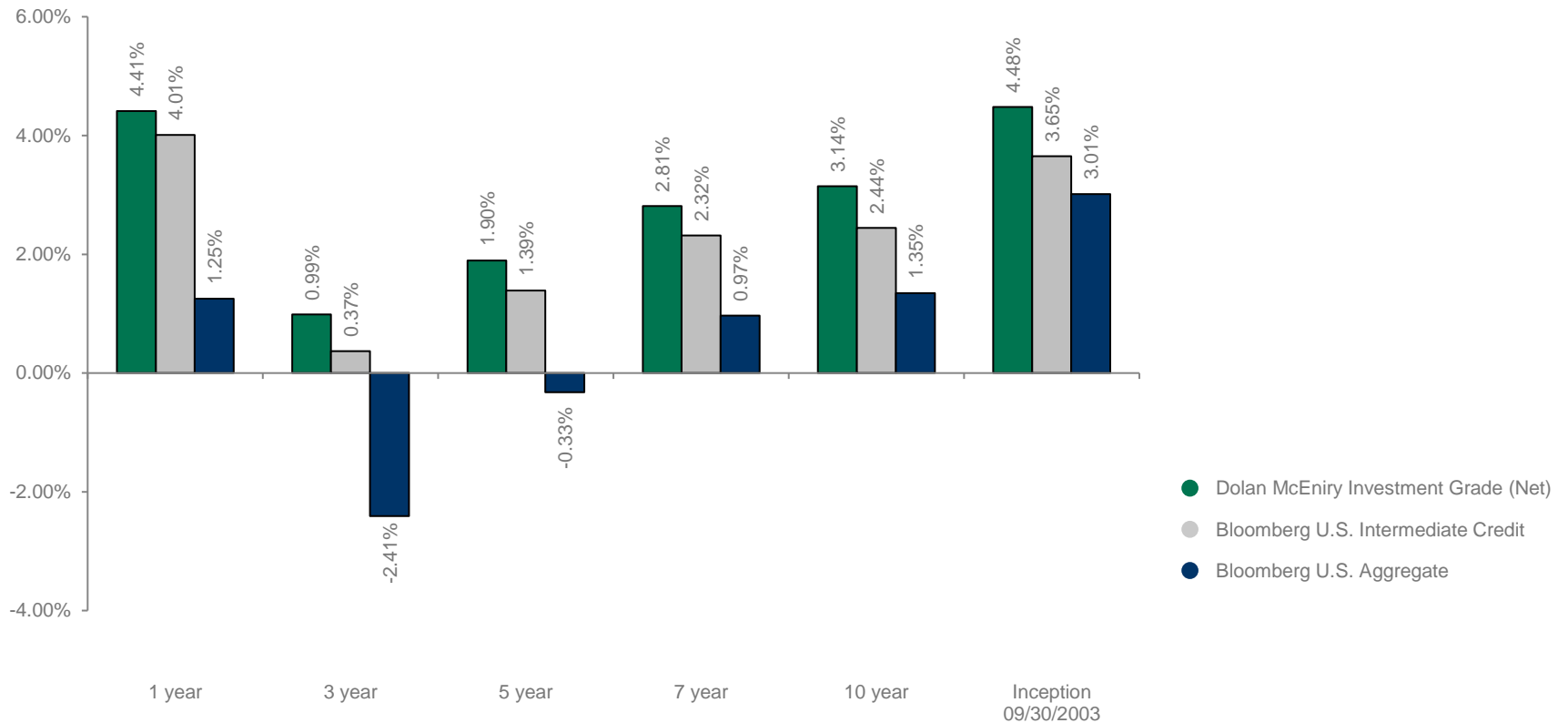

Data through December 31, 2024

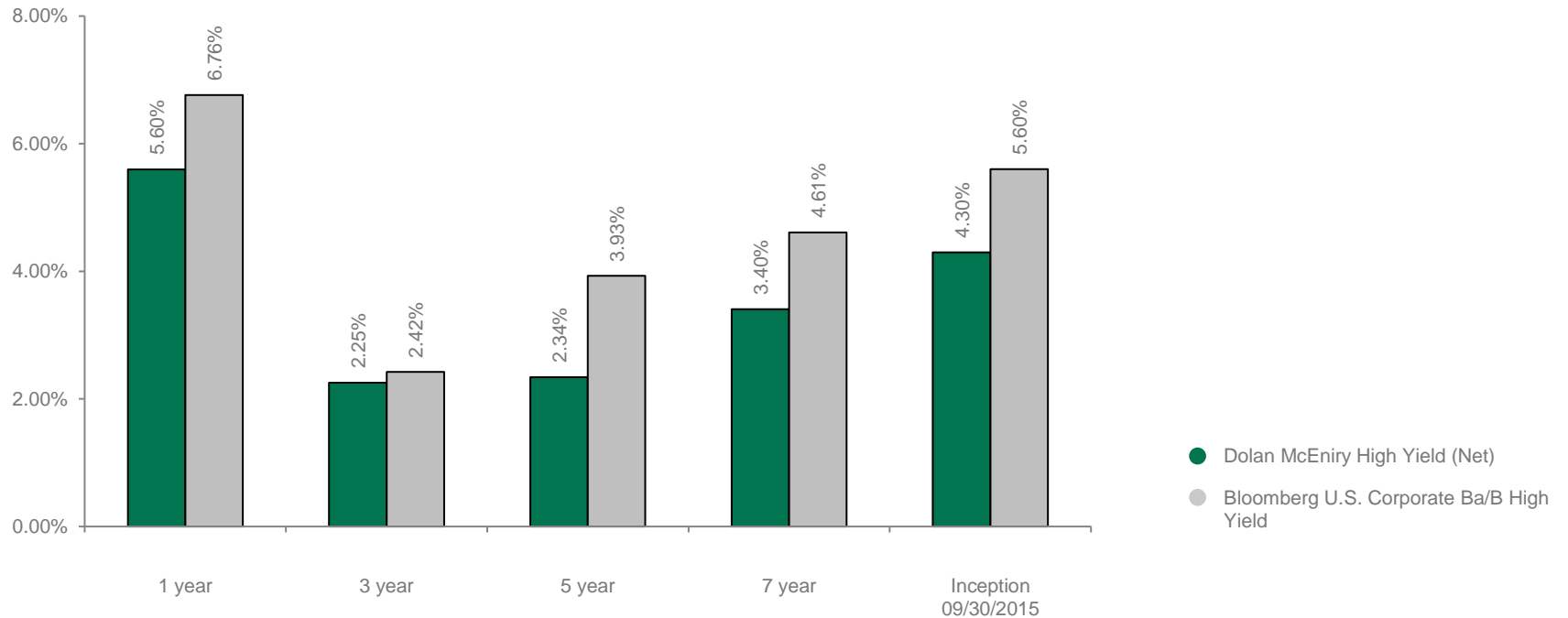

Data through December 31, 2024



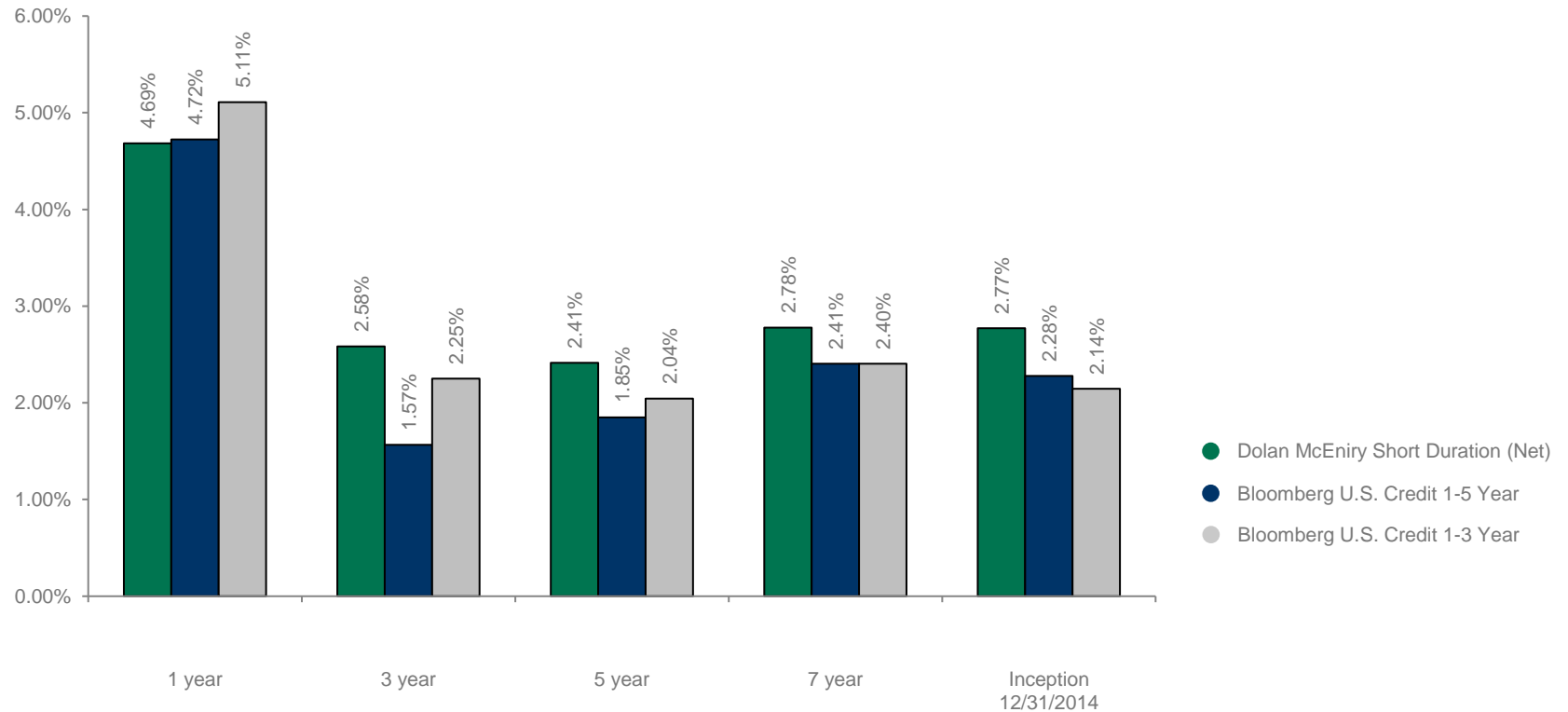

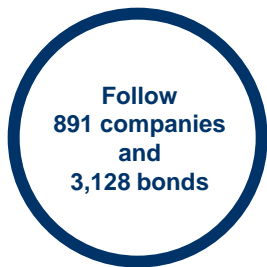

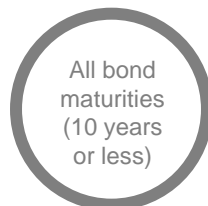
