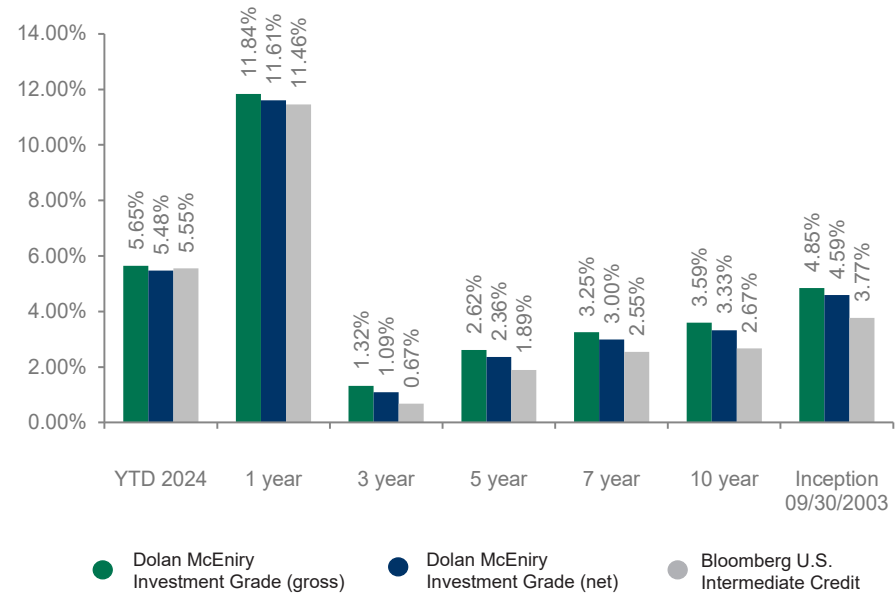

Dolan McEniry Investment Grade Strategy Overview

Dolan McEniry Investment Grade is a fixed income investment product that utilizes entirely U.S. corporate investment grade and U.S. Treasury securities. Dolan McEniry Investment Grade is approximately 100% U.S. investment grade securities. The Dolan McEniry Investment Grade Composite was created on December 31, 2015 and includes investment grade only accounts going back to September 30, 2003.

Investment Strategy and Process

Dolan McEniry searches for bonds that trade at wide spreads and attractive prices but are issued by companies with acceptable levels of credit risk. The firm's core competence is credit analysis and it does its credit research in-house, not relying at all on credit ratings or third party research. The firm takes a lender's approach to fixed income investing.

Dolan McEniry creates concentrated portfolios of its best ideas. The number of issuers in the product ranges from 40 to 45. This number of holdings provides diversification and yet allows clients to benefit from the firm's analysis.

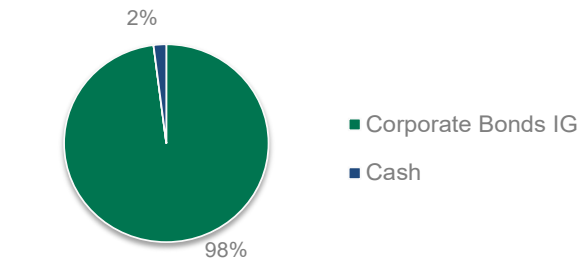

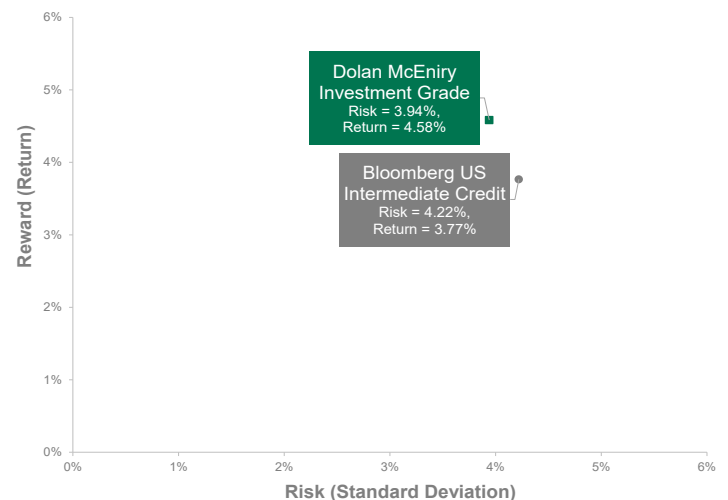

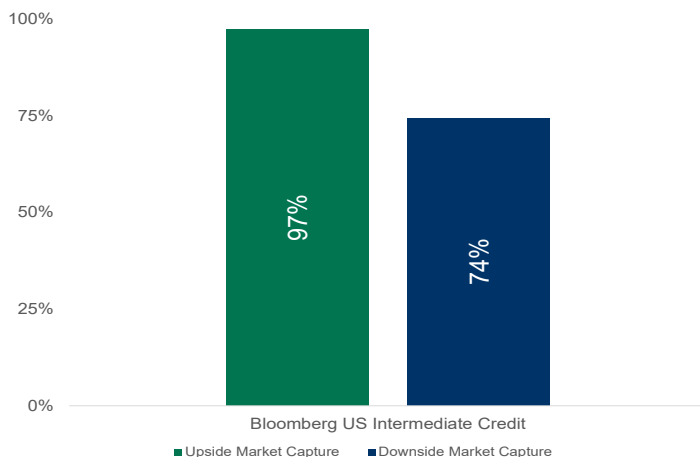

Market Review

During the quarter, Treasury rates decreased significantly as the Federal Reserve commenced its anticipated rate-cutting cycle. Softer economic data in conjunction with easing inflation led the Federal Reserve to cut the fed funds rate by 50 basis points. The current federal funds rate now stands at 4.75%-5.00%. Meanwhile, credit quality remains strong with companies reporting steady earnings during the period.

Treasury rates decreased during the quarter, and the curve became positively sloped for the first time since 2022. The 10 year U.S. Treasury yield decreased from 4.40% to 3.78%, the 5 year yield decreased from 4.38% to 3.56% and the 2 year yield decreased from 4.76% to 3.64%.

Per Bloomberg data, the spread of the Bloomberg Barclays Corporate Investment Grade Index was tightened 5 basis points during the quarter at an average option adjusted spread ("OAS") of +89 basis points. The OAS of the Bloomberg Corporate High Yield Index tightened 14 basis points to +295 basis points at quarter end.

Portfolio Commentary

During the quarter, the Dolan McEniry Investment Grade Composite had a gross return of 4.15% and 4.09% net versus the 4.58% return of the benchmark. Sector attribution versus the benchmark is provided in the following table:

On a relative basis, the Dolan McEniry Investment Grade Composite underperformed the Bloomberg Barclays Intermediate Credit Index by 43 basis points gross for the quarter. The composite's underperformance was driven by security selection. Yield curve positioning and duration had a negative effect on performance versus the benchmark.

Outlook and Strategy

Dolan McEniry believes that client portfolios are positioned to provide reasonable absolute and relative returns going forward. Dolan McEniry's core competence is credit analysis, and we focus on a company's ability to generate generous amounts of free cash flow over time in relation to its indebtedness. Investment safety and risk mitigation are of primary importance as we continue to search for undervalued fixed income securities. As of September 30th, the Dolan McEniry Investment Grade Composite had a +14 basis point yield premium and similar duration to the Bloomberg U.S. Intermediate Credit, which we believe will allow the portfolio to perform well versus the benchmark over time.

Definition of the Firm

Dolan McEniry Capital Management, LLC is an independent investment management firm established in 1997 and is an SEC registered investment adviser. Registration of an adviser does not imply a certain level of skill or training. Dolan McEniry Capital Management, LLC manages fixed income accounts utilizing Dolan McEniry's specific strategies for institutional and individual clients.

Definition of the Composite

Dolan McEniry Investment Grade is a fixed income investment product benchmarked against the Bloomberg U.S. Intermediate Credit Index or Bloomberg U.S. Aggregate Index. In this strategy, the firm utilizes entirely U.S. corporate investment grade bonds and U.S. Treasury securities. Dolan McEniry Investment Grade is approximately 100% U.S. investment grade securities. The Dolan McEniry Investment Grade Composite was created on December 31, 2015 and includes investment grade only accounts going back to September 30, 2003.

Non-fee paying accounts represented less than 2% of the composite assets for all periods shown before 12/31/2019. As of 12/31/2019, there were 2.46% non-fee paying accounts in the composite. Non-fee paying accounts represented less than 2% of the composite assets as of December 31, 2020 and 2.05% of the composite assets as of December 31, 2021.

Benchmark

Bloomberg U.S. Intermediate Credit IndexThe Index is the intermediate component of the Bloomberg U.S. Credit Index. The Bloomberg U.S. Credit Index measures the investment grade, US dollar-denominated, fixed-rate, taxable, corporate and government –related bond markets. It is composed of the US Corporate Index and a non-corporate component that includes foreign agencies, sovereigns, supranationals, and local authorities.

Bloomberg U.S. Aggregate Index

The Index is a broad-based flagship benchmark that measures the investment grade, U.S. dollar-denominated, fixed-rate taxable bond market. The Index includes Treasuries, government-related and corporate securities, MBS (agency fixed-rate and hybrid ARM pass-throughs), ABS, and CMBS (agency and non-agency).

Intra-month cash flows from interest and principal payments contribute to monthly Index returns but are not reinvested at a short-term reinvestment rate between rebalance dates. At each rebalancing, cash is effectively reinvested into the returns universe for the following month so that Index results over two or more months reflect monthly compounding. One cannot invest directly in an Index.

Dispersion

The dispersion of annual returns is measured by the asset weighted standard deviation across gross portfolio returns represented within the composite for the full year.

Performance

Gross returns are presented gross of management fees, custodial fees, and withholding taxes, but net of direct trading expenses. Net-of-fee returns are net of actual investment management fees and direct trading expenses. All returns are based in U.S. dollars and computed using a time-weighted total return. Composite returns are asset weighted individual portfolios computed monthly. Returns for periods exceeding 12 months are annualized. The Dolan McEniry Investment Grade Composite includes both price performance and coupon/dividend income as do the Bloomberg U.S. Intermediate Credit Index and Bloomberg U.S. Aggregate Index. Results reflect the reinvestment of dividends, interest and other earnings.
