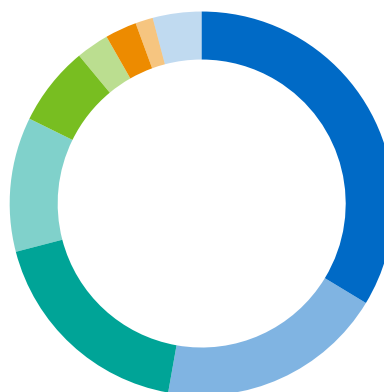

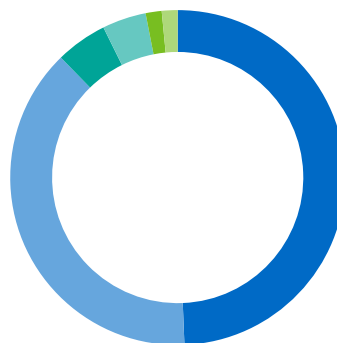

Active Share: Active share is a measure of the percentage of stock holdings in a manager's portfolio that differ from the benchmark index. Weighted Average Market Cap: a weighted average of the price of each security multiplied by the number of shares outstanding all the securities in the portfolio. EPS 5 Yr CAGR: 5 Year Compound Annual Growth Rate, or CAGR, of the company's diluted earnings per share (EPS). Net Debt/EBITDA: is a measurement of leverage, calculated as a company's interest-bearing liabilities minus cash or cash equivalents, divided by its EBITDA. P/E Forward: denotes the weighted harmonic average of all the P/E's of the securities in the fund's portfolio. Return on Equity: assesses a company's net income divided by its shareholders' equity. Annual Turnover: the percentage at which a portfolio replaces its security holdings every year.
