#### **Allocation Guidelines:**

The strategy's allocation is based on a long-term neutral policy of 80% equity, 15% fixed-income and 5% cash. But it has the flexibility to go +/-10%:

Equity: 70% to 90% Fixed Income: 5% to 25% Cash: 0% to 15%


### **Pactive®** Investing


