Sirios Investment Style & Exposure

- * Sirios's concentrated long strategy seeks to deliver long-term capital appreciation.
- * Exposure consists primarily of equity and equity-related securities of approximately 25 – 50 companies.
- * Sirios typically invests in companies exhibiting significant long-term earnings growth potential and attractive valuation.

Sirios Internal Risk Limits

- * Exposure is generally within the range of 90% – 100%.
- * Exposure is controlled by broad sector (Consumer, Energy/Industrials, Financials/RE, Health Care, & Technology/Communication Services).
- * Exposure is also controlled by individual position sizing, with large positions typically 5% – 10% and 15% representing the maximum position size.
