- Sirios typically invests in companies exhibiting significant longterm earnings growth potential and attractive valuation.

### **Sirios Internal Risk Limits**

- ★ Exposure is generally within the range of 90% 100%.
- Exposure is controlled by broad sector (Consumer, Energy/Industrials, Financials/RE, Health Care, & Technology/ Communication Services).
- Exposure is also controlled by individual position sizing, with large positions typically 5% – 10% and 15% representing the maximum position size.

\*The Adviser has contractually agreed to reduce its investment advisory fee and/or reimburse certain expenses of the Fund to the extent necessary to ensure that the Fund's total operating expenses (excluding taxes, interest, extraordinary items, brokerage commissions, fees and expenses attributable to a distribution or service plan adopted by the Fund, dividend and interest expense on short sales of securities and "Acquired Fund Fees and Expenses") do not exceed 1.60% (on an annual basis) of the Fund's average daily net assets (the "Expense Limitation"). The Expense Limitation will remain in place until February 1, 2024, unless the Board of Trustees of the Trust approves its earlier termination. The Adviser is entitled to recover, subject to approval by the Board of Trustees, such amounts reduced or reimbursed for a period of up to three (3) years from the date on which the Adviser reduced its compensation and/or assumed expenses it paid to the extent the total annual fund operating expenses do not exceed the limits described above or any lesser limits in effect at the time of reimbursement. No recoupment will occur unless the Fund's expenses are below the Expense Limitation amount.
